Excerpts from a conversation with James (Jim) Blakeman, LogixHealth's Executive Vice President and Board Member of EDPMA

With extensive ED coding and billing experience, Mr. Blakeman joined LogixHealth in March of 2019 as its Executive Vice President. He is involved in developing and implementing coding policies, and working directly with groups on strategic initiatives and management issues. Prior to joining LogixHealth, over his 35-year career, Jim worked in senior management for two large ED coding and billing companies.

Mr. Blakeman has been a part of EDPMA since the mid-1990s. Jim said "EDPMA is a premier advocacy organization for the practice of emergency medicine, particularly from the business perspective." He points to the current efforts on balance billing and says "that EDPMA has supported a sensible approach, banning balance billing but protecting fair reimbursement for the high value of emergency physician services."

Mr. Blakeman's EDPMA committee contributions span many years. In the mid-1990's, Jim was a Chair of the Provider Enrollment Committee and also participated in the Federal Health Policy Committee and, more recently, he was a cochair of the Quality, Coding and Documentation Committee. Jim comments that "EDPMA committee involvement is a great vehicle for a collaborative exchange of information and ideas, and access to colleagues with expertise in various functional areas." Additionally, Mr. Blakeman was recently elected to EDPMA's Board of Directors and he is looking forward his new role and enhanced ability to contribute to EDPMA and the broader emergency medicine community.
